- Services provided for OOG containers are subject to +100% OOG surcharge except inspection and weighing services. OOG surcharge for inspection and weighing services are applied as +50%.
- Invoices issued are based on the USD selling rate of exchange indicated by Central Bank of the Republic of Turkey.
- Services marked as (\*) are regulated as per the tariff set by the Turkish state authorities and USD rates are determined and continuously revised as per changes in USD/TRY exchange rates.
- If x-ray, sampling and weighing services are requested by customs together with inspection services then these services are applied as 50% discount.
- Services provided for IMO containers are subject to +20% IMO surcharge. Gate, terminal and storage services provided for IMO containers are subject to +50% IMO surcharge.
- Warehouse Services will be calculated based on the 'Charge Base Unit (UEB)' value. The m<sup>3</sup> value of the load is divided by 3 and compared with the weight. The larger value is used as the 'Charge Base Unit'. For loads with a fee base unit value below 1, warehouse services are considered as '1'.
- Listed charges are for standard services only and any additional manning or equipment that may be used for providing non-standard services will be charged separately.
- This document is for information purposes only and SOCAR Terminal reserves its rights to make any changes in the tariff.
